2010 DEALERS AGREEMENT

1. The undersigned hereby agrees to abide by this agreement for the Madison-Bouckville Antique Show conducted on August 20th, 21st and 22nd 2010, Saturday and Sunday. **Each space will be assigned and numbered and approximately 20' deep x 22' wide, with the exception of the booths in the West Row, South South Row and booths 26 thru 36 in the East Row.** These booths are all 20' wide but vary in depth from 25' to 35'. Each dealer must also set up and display each day of the show. Spaces will be assigned. Tent booth dimensions are approximately 18' wide and 16' deep.
2. THIS IS NOT A FLEA MARKET: All articles to be exhibited and offered for sale must be limited to those which will be of credit to the Antique Show. FOOD, CRAFT ITEMS, REPRODUCTIONS and FLEA MARKET ITEMS ARE PROHIBITED. THE UNDERSIGNED AGREES TO REMOVE ANY ARTICLE WHICH MADISON-BOUCKVILLE MANAGEMENT DEEMS IS NOT AN ANTIQUE OR A QUALITY COLLECTIBLE.
3. No persons other than the exhibitors and their employees will be allowed on the field until opening time of 7:00 a.m., Sat., Aug. 21st. **Booths will remain open until 5:00 p.m. on Saturday and 9:00 a.m. - 5:00 p.m. Sunday.**
4. The undersigned agrees to release the sponsors, and the owners of the grounds on which the show is held, from any loss or liability during the duration of the show or the use of the space by the exhibitor, including weather related problems.
5. The exhibitor agrees to be liable for any damage caused by himself or partners on the show grounds.
6. Booth rental - \$195.00 to be submitted with agreement as soon as possible. Tent booth rental - \$375.00 to be submitted as soon as possible. No dealer is allowed to sub-lease any part of the booth they rent from Madison-Bouckville Mgt. for the show.
7. Make checks payable to: *Madison-Bouckville Management*. **(Full payment please - partial payment not accepted.)**
8. If this agreement is terminated for any reason by the exhibitor, the management will retain the rental fee as a liquidation and not as a penalty.
9. Madison-Bouckville Management Inc. reserves the right to reject any and all applications for booth space at the Madison-Bouckville Antique Show.
10. If you wish to rent the booth you had in 2009 write 'same' in the first choice column - if you wish to change to a different booth for 2010, please write 'change' in the first choice column and then write in your new choices for a booth in the 2nd choice and 3rd choice columns. We will attempt to satisfy your wishes - if not, we will assign you to the booth you had in 2009. If this is your first show, please provide us first and second and third choice. If we cannot assign you one of your choices, we will assign a booth as near as possible to one of the spots requested.
11. **You must have a valid N.Y. State Sales Tax Number to participate - to obtain one call (outside N.Y. State) 1-800-972-1233, (inside N.Y. State call 518-485-2889); and ask for Publication #750 & DTF 17. There is no charge.**
12. **The exhibitor agrees to accept and adhere to the unpacking/no selling policy during the period between 1:00 p.m. Thursday, Aug. 19 until Friday, Aug. 20 10:00 a.m. as stated in the show contract cover letter - "Unpacking Policy".**

B. If you wish to rent a tent for your outdoor booth, please follow these rules: The largest 'old style' tent you rent for a 20'x22' booth is a 15'x15' tent - for a 20'x40' booth, a 15'x30' tent, and for a 20'x60' booth, a 15'x50' tent. If you have or intend to rent a **free-standing** tent (no tent stakes) you may use a 20'x20' tent in a 20'x22' booth. Why this rule? A 20'x20' old style tent needs a space of 23'x23' because of tent stakes - this would encroach into the aisle, the booths either side of your booth and also the booth behind your booth.
