The undersigned hereby agrees to abide by this agreement for the **Salt City Winter Antiques Show** to be conducted on January 15, 16 and 17. (Friday, Saturday and Sunday) 2010. Spaces will be assigned by the Promoter (Madison-Bouckville Management Inc.) and each dealer will be notified of their assigned booth number upon receipt of the booth deposit.

This is not a flea market: All articles to be exhibited and offered for sale must be limited to those items which will be of credit to the antique show. No reproductions or new glass and china, please. In addition, the undersigned agrees to remove any article which the promoter deems is not in keeping with the true spirit of the antique show.

No persons, other than the exhibitors and their employees, will be allowed in the building prior to opening time each day of the show. **Set-up** will begin on Wednesday, January 13 at 4 p.m. until 8 p.m., on Thursday January 14 at 8 a.m. until 8 p.m., and on Friday from 8 a.m. until 9 a.m. We urge you to complete your set-up by Thursday evening if possible. Upon receipt of your booth deposit, we will send you your booth number. A limited number of porters (tip) will be available to help you unload and load. The **Exhibitors Entrance** must be used at all times. No exhibitor will be allowed in the main entrance. The exhibitor entrance will be open one hour before show time each day. Arrangements must be made with the show director if earlier entrance is necessary. There is adequate parking available on the fairgrounds at no charge. Anyone bringing travel homes please notify us of this. There is a \$15.00/day charge for electricity (subject to change).

Booths will remain open for business on Friday, January 15, from 10 a.m. until 5 p.m., on Saturday, January 16 from 10 a.m. until 5 p.m., and on Sunday, from 10 a.m. until 5 p.m. Everyone should be in their booths at least 15 minutes prior to show opening. All dealers participating in the show will be allowed access to the building on Saturday and Sunday at 9 a.m. each day to allow time to re-arrange displays, bring in new merchandise, etc. **Move out:** Sunday, January 17th, from 5 p.m. until 10 p.m. No dealer will be allowed to dismantle their booth before 5 p.m. on Sunday, January 17th.

The lessor, sponsor, or promoter shall not be held responsible for any loss that may arise or come to the lessee, his employees or his goods from any cause whatsoever in connection with this contract. The exhibitor hereby relieves the New York State Dept. of Agriculture Division of the New York State Fair and the New York State Industrial Exhibit Authority of all responsibility in connection with the safekeeping of the exhibitors' property while such property is on the New York State Fairgrounds. However, it is agreed precautions will be taken by the promoter to safeguard the property and interest of the exhibitors.

If for any cause whatsoever, it would be impossible to conduct the show, this agreement will be terminated and the exhibitor waives any claims for damage, except the return of any deposit paid.

The promoter agrees to supply adequate booth electrical outlets and electricity (120volts - 500 watts), 24 hour watchman, free parking and janitor service. In addition, the promoter will provide blue back drapes 8' high and side drapes 3' high.

NOTICE: To keep the same booth you had in 2009, we must receive your contract/deposit on or before Nov. 30th 2009. If you are a new dealer, mail your contract, deposit to us as soon as possible.

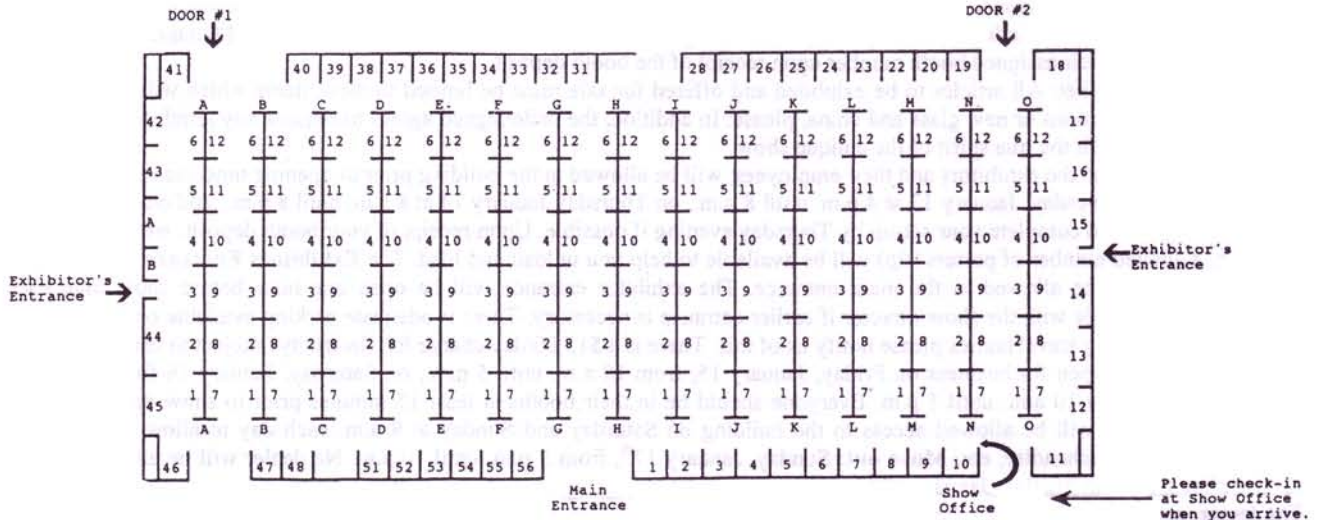
